For the public benefit to advance the education of the public in general and more specifically the residents of, and visitors to, the County of North Yorkshire, particularly the area known as the Yorkshire Dales, in the subjects of archaeology, history, heritage, geology and the natural environment in order to promote a better understanding and management of that local heritage by, for example:

Providing training and experience of a broad range of archaeological investigative techniques which will then be applied to the study of the local heritage;

Undertaking research including fieldwork and excavations into all aspects of the local heritage and publishing and making otherwise available the results of that research;

Providing lectures, guided walks, community projects, activities with local schools and organisations and exhibitions.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

In considering the activities undertaken by SWAAG during 2016, the Trustees have had regard to the guidance issued by the Charity Commissioners on public benefit. Activities during 2016 have included:

The Heritage Lottery Fund funded the Swaledale Big Dig Project comprising documentary research, geophysical survey, test-pit excavation, finds processing and identification, training courses, newsletters, information displays and events, all free of charge to SWAAG members and the public;

A specialist excavation at a Scheduled Monument to look for dating evidence, with support from Historic England and the Yorkshire Dales National Park Authority;

Geophysical survey at Marne Barracks, Catterick Garrison in support of the Ministry of Defence's Operation Nightingale which uses archaeology to help the recovery of injured military personnel;

Geophysical surveying in support of the Long Preston Heritage Group's Heritage Lottery Funded Big Dig Project;

Geophysical surveying Thorns, a medieval monastic settlement, in support of the Dales Millennium Trust's Ingleborough Dales Landscape Partnership Project;

A further exploratory excavation at the West Hagg Farm, Fremington site which was open to members and visitor free of charge and funded from SWAAG reserves;

The Local History Group formed under the aegis of the Big Dig project and open to members and non-member has transcribed the 19th C tithe apportionments for Swaledale and has begun work on the Healaugh and Muker Manor Court Books; all of this work is freely available on the SWAAG web site;

Continued support to the Tyne and Weir Museums' Wall Watch project, a condition survey of Hadrian's Wall;

Finds-processing in support of the follow-up to excavation of a Roman villa site on the line of the Bedale by-pass;

Monthly information and discussion meetings for SWAAG members and guests;

Guided walks led by SWAAG members for the public at intervals during the year, including participation in the annual Swaledale Festival of Music, Arts and Walking; and

Occasional talks for members and the public on aspects of the history of North Yorkshire and surrounding areas, no charge is made.

Section D

Achievements and performance

Summary of the main achievements of the charity during the year

Initially 2016 focussed on the completion and closing down of the Big Dig, a project which received Heritage Lottery Fund financing in 2013 and which aimed to involve the local community and schools in a process of discovery to enhance knowledge of the history of the area, particularly of the villages of Reeth, Fremington and Grinton and to increase the skills levels within the local community in understanding and preserving their local heritage.

During the Project more than 160 people were involved in digging 50 test pits. We worked closely with the local schools; over 90 children took part in digging test pits, surveying and other activities enabling them to learn more about their local heritage. We also ran free courses on a wide range of history and archaeology related topics and led 11 free guided walks.

Towards the end of the project, we obtained scheduled monument consent to investigate the Grinton-Fremington Dykes. Excavations revealed more information regarding the construction of the dyke and samples were submitted for radio-carbon dating.

During the Project, there were 429 participants on 24 courses, 136 participants on guided walks, 335 participants working on test pits, 216 primary school pupils at schools events, 642 people present at events and presentations and 557 visitors to the information tent erected on major digging weekends. Initial projections submitted to the HLF for public participation in all aspects of Project activities have been met or exceeded.

The Project closed with a 2 day public meeting to present the results of the work; Professor Carezza Lewis of the University of Lincoln also presented a paper which put the Swaledale results into a wider national context. The full report for the Big Dig is freely available on the SWAAG web site on the OASIS web site.

SWAAG has led a programme of documentary research (through the Local History Group originally formed as part of the Big Dig) which has transcribed and made digitally-searchable Tithe Apportionment Records for the parishes of Swaledale (available on the SWAAG website and in cooperation with the North Yorkshire County Records Office) and has begun to transcribe the Healaugh and Muker Manor Court Books. The work is feely available on the SWAAG web site.

SWAAG members also carried out at the request of the Ministry of Defence DIO Archaeologist geophysical surveys at Marne Barracks, Catterick Garrison to identify sites suitable for an Operation Nightingale archaeological excavation exercise for wounded military personnel.

During October SWAAG members opened several new exploratory trenches at the West Hagg Farm site, a putative Romano-British settlement dating back to at least the end of the 4th C AD. The dig was open to members of SWAAG and members of the public.

SWAAG continues a series of monthly meetings for members and others for discussion and information and an occasional series of public meetings on subjects of broad historical/archaeological interest, now attracting audiences of some 60 people.

The SWAAG website archives Big Dig newsletters, press reports, excavation and local history blogs and links to SWAAG publications, and a local history database; and is backed-up on the British Library system..

Brief statement of the charity's policy on reserves

At the end of the year the charity retained £9,342 in unrestricted cash reserves. Trustees have reviewed the commercial risks to which the charity is exposed - e.g. possible rental of storage space, work required on the web site; repairs to and replacement of equipment - as well as those "risks" that arise as a consequence of the research work that SWAAG undertakes - e.g. requirements for radio carbon dating, environmental sample analyses, finds conservation, archiving - and have reached the view that it would be prudent for SWAAG to aim to retain a level of reserves of some £5000. Cash over and above the reserves will be used to fund small research projects; larger projects will required to be funded through external sources.

The accounts for the financial year ending 31st December 2016 have been prepared on a Receipts and Payments basis. Included in this report is also a summary of the charity's assets. There were no year end liabilities

The accounts have been independently examined by Mrs Flora Smith, whose report is included in this report.

As recommended by the Charity Commission, the accounts are segregated into unrestricted and restricted cash flows, which are considered separately below.

General: The charity ended the year with a net deficit of circa £10,530 due to expenditure incurred in respect of the Swaledale Big Dig activities leading up to the end of the project in April 2016. The deficit was covered by the (restricted) reserves deriving from the associated Heritage Lottery Fund (HLF) grant received in 2014 and the charity ended the year with total reserves of circa £9,340.

Unrestricted Funds: Over the year the charity has generated a surplus of circa £3,480 on an unrestricted turnover of circa £5,100, compared to a surplus of circa £1,620 on an unrestricted turnover of circa £2,270 in 2015.

Key income streams have been consultancy fees received for geophysical surveys amounting to £1,900; membership fees £1,240; donations (eg at public talks and from members) £245; walks for the Swaledale Festival £120 and circa £222 from talks, book sales and the sale of T-shirts.

Costs to the charity in 2016 totalling circa £3,520 have been higher than in 2015 owing primarily to the expenditure incurred in connection with the West Hagg Farm exploratory excavations. The other major item of expenditure has been insurance at £689 which did not this year receive any contribution from Big Dig funds. Catering expenditure in respect of the members' Christmas dinner of £917.50 was balanced by associated receipts totalling £928 from the members attending

Restricted Funds: In 2013 the charity was awarded an HLF grant of £76,000 to support the Swaledale Big Dig, a two year community archaeology project. The second instalment of the grant, £30,400, was paid to the charity at the end of 2014 and, although it was largely spent during the course of 2015, a year end balance of circa £14,000 was available for activities and commitments leading up to the end of the project in April 2016.

The Big Dig project funds were administered in accordance with the budget agreed with the HLF. There was a degree of overspend in some areas and underspend in others. The HLF agreed to the charity moving monies between the budget heads and overall the project remained within budget. A total of circa £9,390 was spent on approved commitments and activities in January to April 2016. After the payment of a refund of £2,719 to the HLF, the agreed balance of circa £2,400 was transferred to unrestricted funds.


